On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern trelevant legislation and regulatory requirements have not been met.
Other matters not affecting our opinion which we draw to the attention of the authority:
The Internal Auditor's response to Objective M is not consistent with the information in Section 1, Assertion 4 and the prior year external audireport. The Internal Auditor has confirmed no evidence has been obtained regarding the public rights period provided for during 2020/21.
In the completion of the Annual Internal Audit Report and their detailed report, the internal auditor has drawn attention to significate weaknesses in relation to periodic bank reconciliations. The smaller authority must ensure that action is taken to address these areas weakness in a timely manner.
